Dear Zonta Group,

My name is Dezarae Mustain and I have the wonderful opportunity of traveling to the Basque region of Spain for three weeks with Student Diplomacy Corps. This academic based program will not only allow me to study abroad for the summer, but to connect with people from all over the United States and different parts of Spain. My acceptance and completion of my study abroad program will ensure that I am the first student from my high school at Rock River School to complete such an exceptional opportunity.

I am currently sixteen years old and live with my mother. My father lived with us for a couple years before the left when I was seven years old and my brother was thirteen, At this point we witnessed my mom struggle every day to make ends meet, but we also saw her never give up trying to make sure we always had what we needed. On top of working full time, I can remember many weekends when my mom would to work from eight in the morning until noon and sometimes four in the evening. My brother and I both wanted to try and help, but there was not much we could do. When my brother was fifteen he got a job to help out and soon after I started babysitting. It's just me and my mom living together now; my brother graduated in 2010 and headed off to college, as my mother wanted him to get a higher education for a future with better financial stability.

For the past several months I have worked with a team to secure funding for my program expenses, which totaled \$2,500. We did this by hosting fundraising at school events, meeting with community stakeholders, and reaching out to family members for help. In April I was hired at Taco Johns, and began saving my paychecks for this adventure. My mom has paid for my airfare and two unexpected hotel overnights in New York City, NY, and these expenses have left her to undertake the struggle to make ends meet.

Thank you for the opportunity to share my story and support my study abroad program.

Jody Gostas & I met with 1993-94 Past President Bev Morrow just a few weeks before she moved to Redmond Oregon. Bev and husband Doug are natives of Wyoming but decided to move so they would be closer to their son Nathan. Bev said, "I spent 26 years in Zonta and have gained a lot of experiences, friends and travel. I attended four International Conventions, New York, Rotterdam, San Antonio, and Melbourne." Bev served in nearly every Club position (except Treasurer) and was the first and only member of the Cheyenne Club to become Governor of District 12 (2006-2008). One of her memories was being awakened in the middle of the night during a District 12 meeting to a fire alarm and having to stand outside while they secured the hotel. Bev remembers being PR chairman for the Antique Show and getting together with Jody, me (Linda) and a bottle of wine to paint signs for the show. Bev went on to serve as Legislative Advocacy and Awareness Committee Member for Zonta International in 2008-2010. Bev sponsored many members into our club and she will be missed. Emma L. Conlon Service Award

Established in 1962 at the Zonta International Convention in New Orleans, Louisiana, USA, the Emma L. Conlon Service Award is a contest for Z clubs and Golden Z clubs. Named in honor of Past International President, Emma L. Conlon, who graciously underwrote the Award for Zonta International, the Emma L. Conlon Service Awards recognize those clubs whose projects and programs best express the ideals of Zonta International through local and international service and advocacy to advance the status of women worldwide. First place clubs receive US\$1,000; second place clubs receive US\$500; and third place clubs receive US\$250. The award money is to be used for the club's service projects.

Presbyterian Women's Guild (PWG)

Today I spoke to Kay Barnes of the 1st Presbyterian Women's Guild (PWG) about the pillowcase dresses her group makes. The girls in many countries cannot attend school unless they are wearing dresses. Several years ago Nancy Zieman (Sewing with Nancy on Public Television) started a program to sew and donate dresses out of pillowcases for girls in need in Haiti. This became "Creative Kindness" and eventually became a special project for the Cheyenne PWG. It has since expanded to sending pillowcase dresses to girls in Africa, Central American countries and Appalachia. Many women in the Presbyterian Women's Guild who participate in this project take the template home and sew the dresses at their leisure. Occasionally there is a workshop at the church hall for a large number to be done at once.

The Presbyterian Women's Guild is very active. There is an open invitation to anyone who wants to participate in Mission Workshops. People (mostly women) gather at the church hall to make tied quilts and fleece blankets for many different recipients including an Alzheimer research program, veterans' programs, and even the Comea Shelter and Safe house in Cheyenne. You can actually be shown how to make the pillowcase dresses at this time. Kay assured me that sewing skills are not really needed for the Mission Workshop (and you don't need to be Presbyterian!). This productive fellowship meets at 10:00 on the 3rd Saturday of every month (except in July it will be 7/11/15).

There is also another needlework group called Hearts and Hands that makes knitted and crocheted items to be donated. This session teaches knitting and crocheting and creates friendships that are long-lasting. Hearts and Hands meets on the 1st Saturday of each month in the Main Parlor and is also open to anyone who has a desire to improve her needlework, share stories, and donate time and energy to others.

I had taken a few pillowcases into the church office and was consequently connected to Kay Barnes. Kay said donations are always welcome but the most helpful would be "extra wide double fold bias tape." Each dress has the bias tape sewn around the armholes and uses a complete package of the tape. They will also accept donations of cotton fabric (used for the quilts) and yarn, some polyester but NO WOOL FABRICS OR YARN.






