### **Changes to Board of Directors**

Due to a number of unfortunate family events that has taken up Audra Gagnon's time and attention, Audra tendered her resignation from the Board of Directors. While Audra has indicated her desire to continue to engage with the Club as much as possible, she didn't believe that she could adequately attend to director duties (including attending meetings) as she would like. We thank Audra for her time and great work on the Board and look forward to re-engaging her in the work of the Club as her time and circumstances permit.

The Club by-laws call for the members of the Board of Directors to appoint replacement directors for vacancies that occur mid-term. At the December Board meeting, there was unanimous agreement to ask Dasa Robertson to fill in for Audra's term, at least through May, 2022. Dasa has graciously agreed to do so, and we whole-heartedly welcome her to the Zonta Club of Cheyenne Board of Directors.

## **Recent Opportunities to Share Zonta with Others**

On December 15<sup>th</sup>, Denise Parrish had the opportunity to speak to the current class of the Junior Leadership of Laramie County about Zonta -what it is and what we do. It was a great 30 minutes with eight young women at Volunteerism Day. The discussion came around to discrimination or gender inequities they had already experienced in their lives. It was an engaging discussion that included a surprising number of examples, including, but not limited to:

• Women's toiletries cost more than men's so they choose to use men's deodorant;

- The 6<sup>th</sup> penny tax being turned down for new gymnast facilities -- the question was raised whether the result would have been different if it were a male team rather than an all-female team;
- Girls in school getting the same number of hall / bathroom passes as boys even though they may have a greater need with their periods;
- Different treatment at work where boy are allowed to lounge / goof off without consequence but girls are yelled at for lesser offenses;
- The lack of a weight room tailored more for girls due to the expectation they can use the same equipment as the boys;
- Different standards of what is acceptable school clothing for girls and boys; and
- Many more examples including STEM, Scholarships, and a variety of other items.

It was interesting to hear inequities in the context of these young women. As they shared their examples, the question was continually asked, "Do you ever say anything?" Denise was later informed that the Zonta discussion was a hit with these young women. The thank you note is shown below.

Two days later, on December 17<sup>th</sup>, Denise Parrish was the guest lunch speaker at the Cheyenne Vocations Club at St. Mary's Cathedral. This was again a chance to discuss Zonta and the work we do. The topics included human trafficking and domestic violence awareness and prevention activities. The presentation appeared to be well received. Notably, one of the attendees stood up spontaneously to speak briefly about her experience as a survivor of domestic violence. She was moving and passionate in her support of the work Zonta is doing.

### Empowering girls and protecting their rights

Zonta International, a UNICEF USA partner since 1972, helped UNICEF reach thousands of adolescent girls in rural parts of Peru in 2021 with improved education and health services. With Zonta's support, nearly 2,700 adolescent girls have benefited from a reactivation of primary care services, which had been suspended due to COVID–19 pandemic restriction. UNICEF was also able to provide technical assistance and training for health personnel to safely resume services at over 400 facilities.

Through the program, rural communities are learning to embrace girls' rights in other ways too. Teachers are rethinking their classroom practices and schools are adopting "teen-friendly" school plans aimed at preventing pregnancy and gender-based violence.

Zonta has supported many other UNICEF programs over the years. These include key education initiatives in Madagascar and the Global Program to End Child Marriage, through which nearly 8 million adolescent girls have been reached with life skills and school attendance support — all of which help them avoid early marriage and promote gender equality.

In the U.S., Zonta has been an active advocacy partner as well, joining UNICEF USA to push for state legislation banning child marriage with no exceptions, with encouraging results: in 2021, Rhode Island and New York joined Delaware, Minnesota, New Jersey and Pennsylvania in taking this important step. Zonta and UNICEF USA won't stop until laws are in place across the country.

# Ending Human Trafficking

To keep the fight to end human trafficking at the forefront of the national security agenda, the Administration released a new "National Action Plan to Combat Human Trafficking." Globally, an estimated 25 million people are subjected to human trafficking and forced labor, which is responsible for an estimated \$150 billion annually in illicit profits. It erodes the safety and health of communities and transportation networks, the security of the nation's borders, the strength of the nation's economy, and the rule of law.

As human trafficking disproportionately impacts some of the most vulnerable and undeserved members of society, the updated plan responds by addressing the needs of such individuals, families, and communities. As such, it reflects the Administration's commitments to gender and racial equity. The plan also reflects the Administration's commitment to workers' rights and ending forced labor within global supply chains.

The plan remains grounded in an integrated federal response and close collaboration with state and local governments, the private sector, and non-governmental partners and retains a central focus on foundational pillars: prevention, protection, prosecution, and partnerships.
